1. Submit Application and Payment to the **Magic Valley Arts Council** by **JANUARY 31, 2017** to receive discount.
2. Secure your Sponsor and Venue. **Official Entry into the contest requires an Artist to have both a Sponsor and a Venue (location in Twin Falls to display artwork).** Artists are encouraged to secure their own Sponsor (family, civic groups, business, friends, etc.) and Venue (business or public space).
3. Email Artist Statement and a jpg image of entry to artandsoul@twinfallscenter.org. **Artist Statement and jpeg image of work required by FEBRUARY 7, 2017.** Failure to meet the above deadline may hinder the artist in securing a sponsor and/or venue, resulting in disqualification from the competition.
4. Once Application, Payment, Image and Artist's Statement have been received you will be given a contest number and your entry will be posted to magicvalleyhasart.com. Venues and Sponsors who have not pre-selected an Artist may select from online postings.

Venues and Sponsors are invited to an Artist Unveiling event in February to select their Artist(s). Failing to meet the Feb. 7 deadline may put the Artist at risk of not securing a Venue and/or Sponsor.
