All printed photos or jpeg images on a CD submitted with application must be representative of the work to be exhibited. Only original handmade work is acceptable. No commercial or mass produced products will be permitted, except for reproductions of your original work as long as original art is also for sale in your booth.

Jury Requirements:

Submit printed photos or jpeg images on a CD labeled with your name and medium. Please see the application checklist below.

Fees:

Jury Fee \$10.00 non-refundable
11 ft. x 11 ft. Booth space \$85.00
Electrical fee: \$10

The jury fee and booth fee must be paid with two separate checks. Make all checks payable to Magic Valley Arts Council.

If you are not accepted, the booth fee check will be returned to you.

Additional Information:

- * 11 ft x 11 ft Booth spaces are on level grass
- * Limited power available
- * No equipment or materials provided
- * You are to bring your own canopy, chairs and display.
- * Be prepared for seasonal weather.
- * Bring adequate protection and booth tie downs
